- 19. Approved the provisional budget for 2022 with an income of 66 150 € and a total expense 160 000 €.
- 20. Decided to maintain the basic share for 2022 at 1 400 €.
- 21. Having a look on the budget forecast for the coming years, the Committee requests the delegates to be prepared and have a mandate for a decisive vote, during the Committee meeting in 2022, for increasing the basic share to up to 3 400 € per share, effective in 2023.
- 22. Decided the next WELMEC Committee meeting will be held from May 11 to 13, 2022 at PTB Braunschweig or Berlin, Germany (if face-to-face). Decision on the format of the meeting will be taken by March 31, 2022.
